I do not want to eat GE foods which is one reason why I choose to buy certified organic food.</p><p>Thenational organic standards in both the U.S. and Canada prohibit the use of genetically engineered organisms. This is a central tenet of organics.</p><p>The USDA claims that consumers will not reject GE contamination in organic alfalfa if the contamination is unintentional or if the transgenic material is not transmitted to the end milk or meat product. This is not the case. I am a Canadian consumer of U.S. organic foods and food ingredients and I care deeply about the integrity of certified organic foods. GE is fundamentally not organic.</p><p>The GE contamination of organic alfalfa would severely impact the entire organic system in the U.S. and Canada, especially because many different types of organic farmers plant alfalfa to improve soil fertility. This important technique makes it possible to farm successfully without using chemical fertilizers. Contamination by GE alfalfa would eliminate this valuable tool, causing severe economic and agronomic costs to organic farmers.</p><p>Farmers have a fundamental right to sow the seeds of their choice but this choice can be eliminated by GE contamination. This happened in Canada when prairie organic grain farmers had to stop growing canola because there was no way to prevent contamination by cross-pollination with GE canola during the growing season.</p><p>Organic farming provides healthy food grown without pesticides or GE organisms, and builds better soil.
